

Terms of Service

Effective date: February 13, 2026

These Terms of Service (“Terms”) govern your access to and use of Freelant (the “Services”). By using the Services, you agree to these Terms.

1) OPERATOR

Freelant is operated by Attila Tokolics ev., 8481 Somlóvásárhely, Vásár u. 12., Hungary. Contact: privacy@freelant.io.

2) THE SERVICES

Freelant helps freelancers and small teams manage clients, projects and tasks, invoices, and travel plans in one place. We may update the Services over time, including adding, changing, or removing features.

3) ELIGIBILITY AND ACCOUNTS

You must be at least 16 years old to use Freelant. You are responsible for keeping your login credentials safe and for all activity under your account.

4) WORKSPACES AND TEAM ACCESS

Freelant supports workspaces with multiple users, including admin and member roles. Workspace admins can manage membership and may be able to access and manage workspace content, so you should only invite people who should have that access.

5) FREE TRIAL, SUBSCRIPTIONS, AND CANCELLATION

- 30-day free trial: You can use Freelant for 30 days at no cost.
- No card required during the trial: You only enter payment details if you decide to upgrade at the end of the trial.
- Paid subscriptions: Subscriptions are billed monthly in advance and renew automatically unless you cancel.
- Cancel anytime: You can cancel at any time; cancellation generally takes effect at the end of the current billing period.

Payments are processed by Stripe.

6) REFUNDS

We generally do not offer refunds. In edge cases such as duplicate charges or clear billing errors, we may issue a refund at our discretion.

7) ACCEPTABLE USE

Please do not misuse the Services. This includes attempting to breach security, reverse-engineering, scraping, distributing malware, or using Freelant for unlawful activities. We may suspend or terminate accounts that violate these Terms.

8) YOUR CONTENT

You keep ownership of the content you enter into Freelant. You grant us permission to host and process your content only to provide the Services to you and your workspace. Our Privacy Policy explains how we handle personal data.

9) AVAILABILITY

Freelant is provided on an “as available” basis. We aim for reliability, but we do not guarantee uninterrupted uptime, and maintenance may happen from time to time.

10) DISCLAIMERS AND LIMITATION OF LIABILITY

To the maximum extent permitted by law, the Services are provided without warranties. We are not liable for indirect or consequential losses. Our total liability is limited to the amount you paid us in the 12 months before the event giving rise to the claim.

11) TERMINATION

You can stop using Freelant at any time by canceling your subscription. We may suspend or terminate access if you breach these Terms or if we need to protect the Services or comply with law. Data retention and deletion are described in the Privacy Policy.

12) GOVERNING LAW

These Terms are governed by Hungarian law, unless mandatory consumer protection rules apply in your jurisdiction.
